

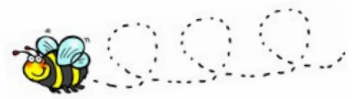

Bankruptcy news Minnesota Lawyers can use FACTS AND FIGURES

Minnesotans filed 730 Chapter 7 and Chapter 13 Bankruptcy cases in February, 2019. In February, 2018, Minnesotans had filed 719 Chapter 7 and Chapter 13 Bankruptcies. That is an increase of 1.52% in case filings year over year in February.

Thus far, in 2019, Minnesotans have filed a total of 1,446 Chapter 7 and 13 Bankruptcy cases. This time in 2018, Minnesotans had filed a total of 1,417 Chapter 7 and 13 Bankruptcy cases. That is an increase of 2.04% year over year.

More bankruptcy news you can use
